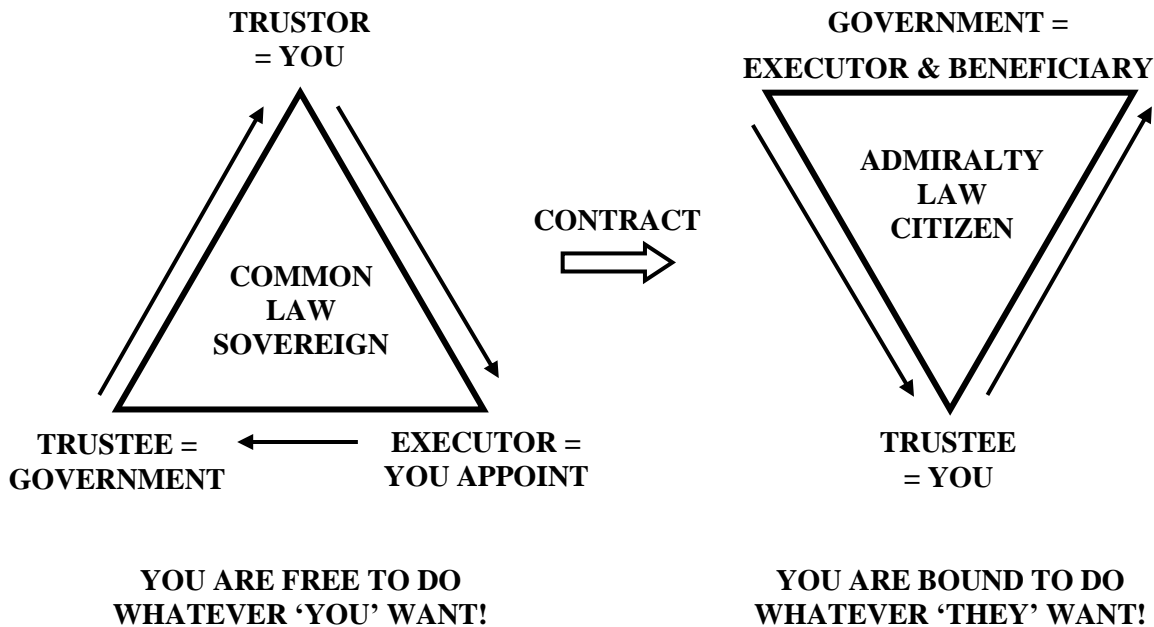


Sovereignty: A Brief Explanation

GOD is the Supreme Sovereign. The United States pledged it's allegiance to GOD as "One Nation Under GOD" and is therefore a Sovereign Nation. While GOD gave you unalienable ^[1] rights, it is the Constitution for the United States that protects them. Your Rights were Stolen! (See the Magna Carta and Treaty of Paris)

^[1] You cannot be 'aliened,' meaning Charged or Penalized for Using your Rights.

You Were Born Free:

Common Law: When you were born, you were born under Common Law which is simply the Law of Responsibility. This means you are fully responsible and liable for all your actions and inactions. This also means that you can do anything you want provided no one is harmed and you commit no fraud.

Live Birth Record: When you were born, a 'Live Birth Record' was created documenting your birth. This record was then sent to the government in exchange for a "Birth Certificate." This exchange created a "Trust" in the form of a Bond ^[2]. The Trust is in your name spelled in ALL CAPITAL LETTERS, with you as the Beneficiary and your parents as the Executors. This Trust is its own entity like a Corporation. Your Parents were Executors and the government accepted the position of Trustee to protect you and this Trust.

^[2] This Bond is a Security and is backed by the Value of your Labor and your ability to Sign Contracts.

You or Your Parents Signed a Contract ^[3]:

The Social Security and Buck Acts: When you or your parents signed you up for Social Security, you were unknowingly entering into a contractual agreement with the government. On the face of it you were getting an insurance policy to take care of you in your retirement. This contract also granted the government the position of Executor and Beneficiary over your Trust and placed you in the position of Trustee.

The premise of this arrangement is that in exchange for your Sovereign Rights which require you to have full liability, the government now assumes the liability and gives you Privileges in return. Because the government is now assuming the liability for you, they have the right and responsibility to tell you what you can and cannot do. As trustee, you are now an Employee of the Trust and must do whatever the Executor tells you under penalty for non-performance of your duties. You can now be Ordered to do something and then Charged and Penalized if you do not perform properly according to the Executor in Charge. This is because “All Law Is In Commerce!” The main purpose of Law is to Maintain Commerce.

The Presumption of Law:

Because this has gone on for so long, it is now the Presumption that everyone in this country is acting as a Trustee and is therefore an Employee, under the watchful guidance and command (i.e. Jurisdiction) of the government. Therefore the people are no longer ‘a party’ to the Constitution as everyone has freely and willfully given up their GOD-Given Rights and Responsibilities in exchange for being ‘taken care of’ by the government. Whoever has Liability, also has Responsibility, and is therefore In Charge.

To this end, the government has brought in Admiralty Law which is the law of Insurance, and created Acts, Statutes, Codes and Regulations to protect their liability from you. Under Admiralty Law, everything you do and don’t do can be Regulated. You must follow the regulations or suffer the consequences. This is why Politicians and Officials such as Judges, Sheriffs, Police officers, etc. can seemingly do whatever they want in an ever increasingly forceful manor. Have you ever noticed that prisoners are referred to as “Trustees?”
