

# AFFIDAVIT (OF FACT OR DEMAND)

An 'Affidavit' is simply a statement of the "Truth, Fact and/or Demand." It can be simply a statement of the Truth or it may contain a "Demand" that something be done about this Truth. An Affidavit is a Bond backed by 'Your Assets!'

## An Affidavit has Five (5) basic parts:

1. The Parties:
  - a. **The Plaintiff(s)** or Person(s) accusing the Defendant(s) through Affidavit.
  - b. **The Defendant(s)** or Person(s) accused whom the Affidavit is directed toward.
    - i. This may include their Address and/or their Public Office.
2. **The "Purpose"** of the Affidavit
  - a. Explain clearly, "Why the Affidavit is being Sent and/or Filed."
3. **The "Evidence"** and Statements of Fact and Truth.
  - a. Make sure this is the Whole and Complete Truth! Your ASSETS depend on it!
  - b. You may use both Constitutional Law and Admiralty Statutes to support your claims.
4. **The "Demand(s)"** (Optional)
  - a. What you Demand the Plaintiff(s)/Accused person(s) do about the Facts.
  - b. Whenever possible set a time limit as to when the demands must be fulfilled.
  - c. Be very clear as to how you will know if they have complied with your demands.
5. **The "Signature and Notary Block"** (See Example Below)
  - a. Have all Affidavits Notarized and always sign in Blue Ink to denote an original.
  - b. If you have "Copy(s)" of the "Original(s)" made, have the Notary "Notarize" the Copy(s) with a statement that "They" have made a "True, Accurate and Authentic Copy of the Original."
  - c. Some Affidavits may use a "Right Thumb Print" as a "Personal Seal."

## Notes:

1. Always have 1 or 2 witnesses when Notarizing, Filing and/or Delivering an Affidavit.
2. Always use 1" margins and keep all writing, seals, page #s, etc. well within these margins.
  - a. Always leave enough space for the Notary Seal, even if you have to add an extra page.
  - b. Many Clerks and/or Recorders may charge extra fees for anything found in the margins.
