I, David A. Darby, Sovereign Citizen of the State of Washington, did, on January 4<sup>th</sup>, AD 2012 did present affidavit of Criminal Complaint to the United States District Court in Tacoma, Washington case # MC 12-5000BHS. The Criminal Complaint was presented to the Federal as a courtesy so that the Federal Court could clean up the constitutional practices of the STATE. The Federal Judge unconstitutionally tried to change the Affidavit of Criminal Complaint into a civil action and dismiss it. This action being unconstitutional is not lawful and does not have any affect on a commercial action. Therefore, since most of the defendants dishonored the commercial affidavit the affidavit went into default. All points not rebutted now stand as law.

*All counter-affidavits (rebuttals) must be signed with the valid legal name of the respondent and properly notarized. Fictitious or incomplete names of respondents or those not containing complete lawful first, middle, last names and valid address, shall not constitute a valid response because they are not properly “authenticated”. (Constitution Article IV § I - authenticated by full faith and credit)*

By law, this County Tax Lien cannot move forward until the Affidavit presented by David A. Darby the purported debtor has been answered by you the duly elected representative of Clark County according to law pursuant to: 3 Am. Jur. 2d Affidavits § 20 (Am. Jur. = American Jurisprudence). **“The courts must accept an affidavit as true if it is uncontradicted by a counter-affidavit or other evidentiary materials.”**
